ASSUMED MANAGEMENT IN JUNE OF 2001. TAKING ON THE NEGLECTED BUILDING AND THE FORGOTTEN RESIDENTS WAS A LABOR OF LOVE AND A COSTLY VENTURE. THE HOME HAD A GRIM REPUTATION AND A PAINFUL HISTORY OF NEGLECT DOCUMENTED BY ENDLESS PAGES OF REGULATORY DEFICIENCIES. IT WAS A CONSTANT OPERATIONAL STRUGGLE TO RESTORE THE NEGLECTED BUILDING WHILE PROVIDING THE BEST POSSIBLE CARE TO THE SEVERELY DISABLED POPULATION.
