LUTHERAN HOME - WINSTON-SALEM, INC. WAS FOUNDED AS A PRIVATELY HELD REST HOME IN 1953. THE AGING BUILDING WAS RENAMED LUTHERAN HOME - WINSTON-SALEM, INC. WHEN LUTHERAN SERVICES FOR THE AGING, INC. ASSUMED MANAGEMENT IN JUNE OF 2001. TAKING ON THE NEGLECTED BUILDING AND THE FORGOTTEN RESIDENTS WAS A LABOR OF LOVE AND A COSTLY VENTURE. THE HOME HAD A GRIM REPUTATION AND A PAINFUL HISTORY OF NEGLECT DOCUMENTED BY ENDLESS PAGES OF REGULATORY DEFICIENCIES. IT WAS A CONSTANT OPERATIONAL STRUGGLE TO RESTORE THE NEGLECTED BUILDING WHILE PROVIDING THE BEST POSSIBLE CARE TO THE SEVERELY DISABLED POPULATION.

IN JUNE OF 2012, THE RESIDENTS MOVED INTO THEIR NEW BUILDING, TRINITY GLEN.
